

**COVID-19 pandemic management measures**  
**The resolution takes effect from 16 December 2020, 00 hrs.**  
**The quarantine has been extended until 31 January 2021, 24 hrs.**

<p><b>Movement within the country</b>  <b>Effective from 16 December 2020</b></p>	<p>Movement is allowed only when necessary          Leaving the place of residence is allowed:</p> <ul style="list-style-type: none"> <li>• on the way to work (for work matters);</li> <li>• point of sale;</li> <li>• to one's own real estate object;</li> <li>• funerals;</li> <li>• health care and other essential services;</li> <li>• to take a walk in open spaces for no more than one family or one household members;</li> </ul> <p>to visit people who are ill or unable to take care of themselves</p>
<p><b>Movement within the country during the festive period from 16 December 2020, 00 hrs. until 31 January 2021, 24 hrs.</b></p>	<p>The departure of persons outside the territory of the municipality of their place of residence is restricted.          Except:</p> <ul style="list-style-type: none"> <li>• when the death of close relatives occurs;</li> <li>• to perform work when the place of employment is in another municipality;</li> <li>• for necessary medical assistance;</li> <li>• traveling to the airport or ferry. (Necessary to have travel tickets )</li> </ul> <p>The restriction does not apply to persons who travel to a municipality other than their municipality of residence where they own real estate.</p>
<p><b>Communication (socializing)</b>  <b>Effective from 16 December 2020.</b></p>	<p>Communication only among individuals within one family or one household. Close contacts of more than one family or household are not allowed.          Except:</p> <ul style="list-style-type: none"> <li>• emergencies requiring assistance,</li> <li>• taking care of people who are ill or unable to take care of themselves.</li> </ul> <p>Private celebrations in public and private spaces can only take place if no more than one family or one household participate.</p>

<p><b>Shops, markets and other grocery stores</b>  <b>Effective from 16 December 2020.</b></p>	<p>Only grocery stores shall operate</p> <p>The operation of shops, including shops in shopping and/or entertainment centers, marketplaces and other public outlets, is prohibited.</p> <p>The prohibition does not apply to:</p> <ul style="list-style-type: none"> <li>• stores whose main activity is the sale of food, veterinary, pharmacy, optical goods and orthopedic technical devices;</li> <li>• food trade in markets and other public areas;</li> <li>• online trade and when goods are delivered to natural and legal persons or picked up at pick-up points.</li> </ul> <p>In non-prohibited stores:</p> <ul style="list-style-type: none"> <li>• 10 m<sup>2</sup> of sale space per visitor must be provided or no more than one person is served at a time and other conditions set by the State</li> </ul> <p>Commander of National Emergency Operations shall be ensured</p>
<p><b>Services</b>  <b>Effective from 16 December 2020.</b></p>	<p>Contact services shall be reduced</p> <p>It is prohibited to provide:</p> <ul style="list-style-type: none"> <li>• beauty services;</li> <li>• other services, during the provision of which contact between the service provider and the recipient is unavoidable;</li> </ul> <p>Allowed:</p> <ul style="list-style-type: none"> <li>• psychological support services that cannot be provided remotely.</li> </ul> <p>At service points that are not prohibited, a service area of 10 m<sup>2</sup> per visitor shall be provided or no more than one person can be served at a time, and other conditions set by the State Commander of National Emergency Operations shall be ensured.</p> <p>Premises intended for the provision of accommodation services on the basis of rent, sublease or use may be used only for the isolation of persons</p>

**Education  
Effective from 16  
December 2020.**

Only distance learning shall be provided  
Kindergarten, pre-school and primary education shall be carried out remotely, except for children whose parents (adoptive parents, guardians) do not have the opportunity to work remotely.

Education in schools according to primary, basic and secondary education programs shall be carried out remotely, except for students educated in special schools and special classes
